

CNFN Membership

Membership to Child NGO Federation-Nepal (CNFN) is open to all institutions and organizations working towards child rights and other child related issues including their social security. Membership is granted without any bias and prejudice to all those organizations and institutions who have the goals and objectives to work towards bettering the lives of the children and giving them a respectful and just life.

However, organizations seeking its membership should have registered themselves with the local administrative body of the Government of Nepal, and also affiliated to the Social Welfare Council (SWC), an apex body of national and international organizations working in Nepal.

Terms and conditions of receiving CNFN Membership

1. Should be a legal body registered with the local Administrative Body of the Government of Nepal.
2. Should be affiliated to the Social Welfare Council (SWC).
3. Membership is granted upon receipt of applicable registration fee and annual charges which are as follows:

a. Registration Fee (one time)	-	Rs. 300.00
b. Annual charge (every year)	-	Rs. 100.00
c. Life Member	-	Rs.3000.00

Please note that submission of membership application do not however guarantee granting of membership. All applications are subject to scrutiny. If details given in the application form are found untrue and all mentioned required documents and not submitted and is not up-to-date, granting of membership can be cancelled or withheld. The right of granting CNFN membership totally lies with CNFN.

All applications should be accompanied by the papers/documents mentioned in the application form. Applications forms can be obtained through e-mail upon request or direct from the CNFN secretariat at Bhrikuti Mandap, Kathmandu.
